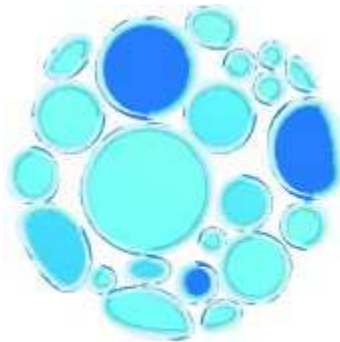
The first connection already being established as Wantz-Consulting is the exclusive reseller, in Luxembourg, of the Polish water filtering products from the UST-M company.
